Kamil Zajączkowski – Ph.D., Director of the Centre for Europe of the University of Warsaw for the 2020–2024 term (between 2016–2020, he was the Deputy Director of CE UW for Research and International Cooperation). His research interests focus on the following problems: the role and position of the EU in the world, EU relations with the countries of Sub-Saharan Africa, and development aid, and he is the author of several dozen scientific publications on these subjects. He has participated in numerous international research projects, and is the former manager of three projects under grants from the Polish Ministry of Foreign Affairs. He has provided lectures at over 20 European and Asian universities, including those in Paris, Istanbul, Indonesia, and China. He is a member of several scientific councils of foreign journals including the “On-line Journal Modeling the New Europe” journal. A commentator on international affairs on radio and television.

Agnieszka Legucka – Doctor Habilitatus, and a senior research fellow of the Russia in Eastern Europe Program at the Polish Institute of International Affairs (PISM). She is an associate professor of security studies at the Faculty of Business and International Relations in the Academy of Finance and Business Vistula in Warsaw. She is also deputy editor-in-chief of the journal “Sprawy Międzynarodowe” [International Affairs]. She was vice-rector at the National Defence University in Warsaw from 2015 to 2016. She holds two master degrees in International Relations (2002) and East Studies (2003), obtained from Warsaw University. She obtained a Ph.D. in Security Studies at the National Defence University in 2005. In 2014, she received her habilitation (a senior doctorate) from the National Defence University. Her areas of expertise include Russian foreign and internal policy, security issues and conflicts in the EU’s Eastern Neighbourhood, EU-Russia and NATO-Russia relations, Russian disinformation, and hybrid threats. Her recent work includes monographs and several analytical studies concerning the domestic and foreign policies of Russia, including the report “Kremlin Kids: The Second Generation of the Russian Elite” (PISM, 2019).

Agata Włodkowska – Doctor Habilitatus, graduating from the Faculty of Political Science and Journalism at the University of Warsaw in 2002. Since 2005, she has held a Ph.D. in International Relations from the University of Warsaw. In 2014, she received her habilitation (a senior doctorate) from the Faculty of Political Science and International Studies at the Nicolaus Copernicus University in Torun. Her key research areas concern: international relations and security in the post-Soviet space, the Russian Federation and the post-Soviet states' foreign and security policy, Poland's foreign policy, and the feminist approach in international relations. She is the co-author and coordinator of the project *Women in Polish Political Science. From Diagnosis to Cooperation*. She is the author and editor of numerous articles and books.

Tomasz Stepniewski – Doctor Habilitatus (Polish Academy of Sciences, Warsaw, Poland), Associate Professor at the Institute of Political Science and Public Administration, Faculty of Social Sciences, The John Paul II Catholic University of Lublin, and Deputy Director at the Institute of Central Europe in Lublin (www.ies.lublin.pl), Poland. Prof. Stepniewski has been involved in a number of research-projects dealing with development in the post-Soviet space while at the same time engaged (by invitation) in expert-level discussions and negotiations on related issues. A former research fellow at the Harvard Ukrainian Research Institute in 2005, 2006, and 2015, Carnegie Moscow Centre, and others. His main research interests include the EU's policy towards its eastern neighbourhood, international relations of the Commonwealth of Independent States, and Russia's policy towards Eastern Europe. Andrzej Szabaciuk – Ph.D., Historian and political scientist. Assistant Professor at the Department Political Theories of Eastern Studies, Institute of Political Science and Public Administration at the John Paul II Catholic University in Lublin. Senior Analyst, the Department of Eastern Europe, at the Institute of Central Europe in Lublin. An intern at the Institute of Sociology, Russian Academy of Sciences (2013), and the Ukrainian Catholic University (2013). A visiting fellow at the Nanovic Institute for European Studies at the University of Notre Dame, USA (2019). Research interests: international relations within the post-soviet

area, the security of the Eastern European region, migration, ethnic and religious policies, the situation of national and religious minorities in the East, and the role of the Catholic Church in the socio-political life of the countries of the former Eastern Bloc.

Agata Domachowska – Associate Professor (dr hab., prof. UMK) at the Faculty of Humanities (Nicolaus Copernicus University, NCU) and a senior analyst at the Institute of Central Europe (Department of the Balkans).
