





# Transatlantic Relations:

## Reset, Rebalance, and Renewal?

2018 saw a mix of progress and new tensions for the Euroatlantic community. Allies reached important decisions on NATO enlargement and command structure reform as well as sanctions on Russia even as they disagreed on other issues such as trade and the nuclear agreement with Iran. U.S. Secretary of State Mike Pompeo framed this as part of a necessary "reset" of relations for the 21st century in an interview with the Wall Street Journal, while German Foreign Minister Heiko Maas applied the term "rebalance" in a major speech on European unity.

Ahead of events such as European Parliament elections and NATO's 70th anniversary in 2019, this seminar offers an opportunity for officials and experts from both sides of the Atlantic to take stock, exchange perspectives, and consider policy ways ahead.
